

# LIMITED WARRANTY

Crash Data Group Inc. ("CDG") warrants to the original end user that the EDR Retrieval Kit for Tesla Vehicles and related cables and adapters ("EDR Retrieval Kit for Tesla Vehicles Product") distributed through its authorized distributors to be free from defects in material and workmanship, in accordance with the following:

For a period of 12 months after delivery to the original end user, CDG will repair or replace, at CDG's option and at no charge to the end user, any EDR Retrieval Kit for Tesla Product which, under normal conditions of use and service, proves to be defective in materials or workmanship. However, this warranty does not cover expenses incurred in the removal or reinstallation of any EDR Retrieval Kit for Tesla Vehicles Product, whether proven defective, and does not cover EDR Retrieval Kit for Tesla Vehicles Product not purchased from a distributor authorized to sell EDR Retrieval Kit for Tesla Vehicles Product. This warranty is limited to the original end user and is not transferable. Repaired and replacement EDR Retrieval Kit for Tesla Vehicles Product shall be warranted for the remainder of the original warranty period warranty and this warranty shall not be extended with respect to such products.

To obtain performance of this warranty, contact CDG or visit our office. A dated purchase receipt or other proof that the EDR Retrieval Kit for Tesla Vehicles Product is within the warranty period will be required to honor your claim. Carefully pack the unit and ship prepaid to the servicing location. For further information:

Also excluded from this warranty are the correction of improper installation and the elimination of any external electromagnetic interference.

THIS WARRANTY SETS FORTH YOUR EXCLUSIVE REMEDIES WITH RESPECT TO THE EDR RETREIVAL KIT FOR TESLA VEHLICES PRODUCT COVERED BY IT. CRASH DATA GROUP WILL NOT BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL OR PUNITIVE DAMAGES ARISING FROM THE SALE OR USE OF ANY EDR RETREIVAL KIT FOR TESLA VEHLICES PRODUCT, WHETHER SUCH CLAIM IS IN CONTRACT OR TORT. NO ATTEMPT TO ALTER, MODIFY, OR AMEND THIS WARRANTY SHALL BE EFFECTIVE UNLESS AUTHORIZED IN WRITING BY AN OFFICER OF CRASH DATA GROUP.
